#### SD Game, Fish and Parks (GFP) Land & Water Conservation Fund (LWCF) 2024 Grant

The LWCF provides up to 50% reimbursement for approved outdoor recreation projects that seek at least \$10,000 in grant assistance. Grants will be awarded for development or renovation of public outdoor recreation facilities. Priorities identified by the public include unpaved trails, swim beaches, fishing areas, canoe & kayak water trails, nature areas/open spaces, playgrounds, dog parks, and picnic areas. Public outdoor recreation projects sponsored by city, county, township, and tribal governments are eligible.

Federal Home Loan Bank - Community Investment

Regional Food Business Center (RFBC) Update

Applications for the <u>Business Builder Sub-Award Grants are now open and due April 30, 2024</u>. These grants support regional projects and businesses aiming for expansion and growth. Average award amounts est. \$35,000 - \$50,000. Growers, producers (commodities, fruits, vegetables & livestock), aggregators, distributors and food access points (food co-ops, farmers markets, etc.) are eligible. For-profit private sector and non-profit organizations that are small to mid-sized local food value chain businesses are encouraged to apply. Grants may support staff time, business planning activities, software implementation, purchase of equipment, value chain and supply chain coordination and innovation, product development and marketing.
