Sanborn County Commissioners met in regular session on Tuesday, January 20, at 9:00 a.m. with Chairman Jeff Ebersdorfer presiding. Present was Jeff Ebersdorfer, Steve Larson, Earl Hinricher, Gary Blindauer, and Duane Peterson. Motion by Peterson, seconded by Larson, to approve the minutes from the January 6 meeting. Motion carried. Motion by Peterson, seconded by Blindauer to approve the agenda as presented. Motion carried.

Motion by Hinricher seconded by Blindauer to rescind both motions from the January 6th meeting, for approval for two plats for the Woonsocket School District of which landowners are Jack & Bernie Davis. Motion carried. Reasoning to rescind both motions is an incorrect description of the property and grammatical errors.

Motion carried.

Tami Ziebart, Director of Equalization, presented a variance for Richard Moe & Roger Moe. By recommendation from the Planning & Zoning board, motion by Larson, second by Blindauer, to approve the variance as presented for Plat of Tract 1 of Moe Addition in the NE/4 of the SE/4 of 22-106-61 of Letcher Township, for purposes of the plat being less than 10 acres, which requires a variance. Motion carried.

Ebersdorfer declared back to Board of Commissioners.

RESOLUTION 2026-5 – VACATING A CERTAIN PORTION OF DITCH 16, LOCATED IN 107-61-29 AND 107-61-32

Motion by Peterson, seconded by Larson to approve Resolution 2026-5, to vacate a certain portion of Ditch 16. Motion carried.

WHEREAS, the Sanborn County Commissioners having received a petition pursuant to SDCL 31-3-6 et al., for the vacation of a certain portion of public Drainage Ditch 16 located in Silver Creek Township; and

WHEREAS, the Petition contains the signatures of two thirds of the adjacent landowners or all adjacent landowners if there are fewer than three; and

WHEREAS, the matter was presented at a public hearing, properly noticed, including publication in the official newspapers of the county, once each week for at least two consecutive weeks; and

NOW, THEREFORE, having considered all information, opinions, and arguments presented, being fully advised in the premises and good cause appearing, it is hereby

FOUND AND DETERMINED that the public interest will be better served by the action, to wit: to vacate a small section of County Drain 16, located in the South East Quarter of Section 29, and the North East Quarter of Section 32, all in T107N, R61W (Silver Creek township) Sanborn County, SD; and

the South East Quarter of Section 32, in T107N, R61W (Silver Creek Township) Sanborn County, SD; and the West Half of the North East Quarter of Section 29, and the West Half of Section 32, all in T107N, R61W (Silver Creek Township) Sanborn County SD; and
WHEREAS, the specified parcels are as follows:

The South East Quarter of Section 29, and the North East Quarter of Section 32, all in T107N, R61W (Silver Creek township) Sanborn County, SD;

The South East Quarter of Section 32, in T107N, R61W (Silver Creek Township) Sanborn County, SD;

The West Half of the North East Quarter of Section 29, and the West Half of Section 32, all in T107N, R61W (Silver Creek Township) Sanborn County SD; Every part of this ditch north of 232nd street; and

WHEREAS, the subject portion off "Ditch16" is located upon Sections 29 and 32 of Silver Creek Township, which Ditch is identified on the County Drainage Ditch map, located in the County Commissioner' room of the Sanborn County Courthouse, in Woonsocket South Dakota.

BE IT RESOLVED that the Sanborn County Board of Commissioners state that this section of the ditch now be vacated/abandoned from the County Drainage system.

RESOLUTION 2026-3 – ESTABLISHING A R&B LEVY

Motion by Blindauer, seconded by Peterson, to approve Resolution 2026-3 to establish a Road & Bridge Levy. Motion carried.

WHEREAS, Sanborn County has deteriorating and substandard county roads and bridges; and

WHEREAS Sanborn County has inadequate revenue to meet the minimum road and bridge maintenance required; and

WHEREAS, SDCL 10-12-13 allows the Board of County Commissioners to establish a levy for the creation of a reserve fund to be accumulated and used for the purpose of maintaining, repairing, constructing and reconstructing roads and bridges in Sanborn County; and

WHEREAS taxable valuation within Sanborn County is less than one billion dollars;

THEREFORE, BE IT RESOLVED, by the Sanborn County Board of Commissioners that there shall be an increased levy in the amount of One Dollar (\$1.00) per one thousand dollars of taxable valuation of property located within Sanborn County; and that the monies from the levy shall be placed into a reserve fund known as the Sanborn County Highway and Bridge Reserve fund; and be it further;

RESOLVED that said funds shall be used solely for county road and bridge purposes, and that the County Highway budget shall not be reduced on account of the special funds available.

Upon roll call vote the following was recorded: Larson, aye; Hinricher, aye; Blindauer, aye; Peterson, aye; Ebersdorfer, aye; Motion carried.
